2023 Arbor Day Planting Application

Ulster County in partnership with Ulster County Soil and Water Conservation District

Introduction: The Ulster County Department of the Environment and Ulster County Soil and Water Conservation District are accepting applications supporting municipal tree planting projects that will benefit the community and public. Tree plantings are important and provide many ecosystem services including; repairing and protect soil, storing carbon dioxide and aiding in climate change mitigation, providing breathable oxygen, reducing stormwater runoff (reducing waterway erosion and pollution), and protecting and providing food for many wildlife species. Ulster County will demonstrate its commitment to this initiative by supplying trees and materials to municipalities or municipal groups selected via the application process. Projects will be coordinated and implemented by the applicant. **To be considered for this opportunity, please fill out the application on the following page and submit it to the Ulster County Department of the Environment at: Environment@co.ulster.ny.us.**

Municipalities pursuing the NYS Climate Smart Communities certification program may be eligible for points under CSC PE6 Action: Local Forestry Program or other appropriate action. Notes:

1. The number and size of trees awarded per project will depend on number of projects supported and available resources.
2. Applications will be accepted on a rolling basis and projects must be completed in the 2023 calendar year.
3. It is anticipated the plantings will take place in either the spring or fall. Planting events do not have to take place on Arbor Day.
